- Sports Direct warehouse

Stricter enforcement

- Southampton: 12 men arrested in rape and modern-day slavery investigation
- Northumberland: 14 people have been arrested in a multi-police force operation
- Yorkshire: Man charged with slavery offences over missing Vietnamese girls
- Wycombe: Four arrested in modern day slavery raids
- Glasgow: Trafficking probe after Vietnamese girl found in street
- Suffolk: 59-year-old man arrested on suspicion of slavery charges
- Hampshire: Three Arrests After Modern Day Slavery Raids
- Lancashire: Women rescued by police as part of human trafficking probe
- Slough: Raids carried out in Slough as part of modern slavery crackdown

Three step process for law firms to adopt

- Understand and review the top number of suppliers across your business
- Embed modern slavery criteria in the procurement process
- Only promote and endorse services that have strong modern slavery processes
